The following documents in **Original** will be required on the day of interview:

1. Certificate as issued by UGC for JRF/NET/Admission to Ph.D. (as per the category applicable)
2. Net/JRF Score Card
3. Seven (07) copies of the research proposal uploaded at the time of online registration (back to back printouts advised)
4. Proof of identity (any one from Voter ID/Aadhaar/Driving License/Passport/ID Card issued by a government institution)
5. Class X Certificate for verification of date of birth
6. Master's degree in Education (Marksheet and Degree)
7. Grade to percentage conversion proof (if applicable)
8. M. Phil. in Education (Marksheet & Degree , if applicable)
9. Reserved category certificate whichever applicable (SC/ST/ /PWD/EWS/ OBC (Non-Creamy layer).In case of EWS and OBC (Non-Creamy layer) please ensure that the certificate is issued on or after 1st April 2024.

Instructions for the Candidates:

1. The list of all eligible candidates for Ph.D. interviews in the department will be uploaded on the departmental website <https://cie.du.ac.in> in due course of time. Candidates are advised to check the departmental website regularly for further updates.
2. No personal intimation/emails/WhatsApp messages will be sent to the candidates. Further, the Department will not be responsible for the failure of candidates to check such updates.
3. Candidates will have to appear in-person for the interview.
4. No request for change of category, as filled in the form, will be entertained.
5. Candidates will have to defend the title and area as proposed during upload of the research proposal in the interview. Any change of these will lead to disqualification and the candidate will not be allowed to appear for the interview.
6. Merely appearing in interview does not guarantee one's eligibility and/or claim to admission to Ph.D. program in Education 2024-25.
7. If a candidate is found ineligible during the verification of documents, he/she would not be allowed to appear in the Ph.D. interview.
8. If the candidate is found ineligible at any subsequent stage, the candidature will be cancelled.
